### SIDEWALKS NEEDING REPAIR! Several

GNA residents have inquired as to whether our association can help with getting sidewalks repaired in their areas. We have begun developing a plan and have measured and mapped all of the sidewalks within our boundaries where the cement has eroded, heaved up, broken apart, etc. These forlorn walkways create a tripping hazard (not to mention making snow shoveling a nightmare). We are researching what



grants we can apply for to get some funding for this very expensive project, and we will be contacting vendors to get both estimates on cost and timeframes. It's possible because of project length and available funding that we *might* have to split the project into phases, but be assured we will keep this initiative front and center. Once we have all the pieces in place, we'll publish the project scope here in the newsletter. 

#### GNA HOMES: 36 Bluff Street — John P. Hess, by Mary Lou McGinn

John P. Hess was born in 1852 in Lancaster County, Pennsylvania. Census records list his parents as John R. Hess and Anna Stauffer. According to his obituary, "He was the son of a prominent Mennonite preacher whose congregation later built a church in honor of the pastor's work in the community.

"He moved to Pottawattamie County in 1879 and established himself on a farm east of the city. Later he began representing eastern investors seeking to place loans on Iowa farm properties. He remained on the farm doing this work until 1890, when he associated himself with F.J. Day and formed the firm of Day and Hess, real estate brokers and insurance agents. The Hess building on Pearl and Main streets was built by this firm.

"Mr. Hess purchased the Day interests in the firm in 1914 and established the firm of J.P. Hess Company. He remained in this business until 1928."

He served as president of the Abstract and Title Guarantee Company

and secretary of the Day and Hess Company. In 1918, he was president of the J.P. Hess Company (real estate, loans, surety bonds and abstracts). He served as president of the school board in 1903, 1904 and 1905. He was a member of the Elks and Kiwanis Clubs, and an active member of the Council Bluffs Real Estate board before his retirement. He was an elder in the First Presbyterian church.

Susan B. Konigmacher and John P. Hess were married in Pennsylvania before moving to Iowa. The couple had three sons: John J., Edwin and Adam. Susan was on the board of the Creche, a ladies charitable organization founded in 1901 to help deserted wives and children.

The nomination of the Willow/Bluff/Third Street District to the National Register of Historic Places lists John P. Hess as the probable builder of the houses at both 36 and 40 Bluff Street. The abstract for the property at #36 verifies that Susan and John P. Hess owned both lots.

The Hess family lived at **40 Bluff Street** (built c.1900) until 1910. Listed as a Foursquare Variant of the Free Classic Queen Anne style, the house retains clapboard siding; wide eave overhang with modillion blocks; wrap-around porch with <sup>3</sup>/<sub>4</sub> height round columns and pedimented entry; two-story bay window; canted corner on the southeast and cut-away bay on the northeast corner. In 1910, the Hess family moved to their new home at **36 Bluff Street**.

According to the National Register nomination of the district, the 1896 Sanborn map shows a house on this lot, but with a different footprint. The abstract refers to it as "a brick house". The width of the masonry walls in the basement suggests that the new house, built c.1910, may have been built on the foundation of the older brick house. City directories show people living at this address between 1894 and 1910, while it was owned by Hess – possibly as renters.

The style of the house at 36 Bluff Street reflects the Prairie style of architecture that was made popular by Frank Lloyd Wright during the early part of the century and continuing through c.1920. The National Register nomination of the district notes the narrow clapboard siding, very wide eave overhang, flared eaves, original Prairie/ Craftsman type windows with leaded glass, and a front door with side lights and transoms. The triple windows above the porch and the classical porch columns add a touch of the Colonial Revival style, also popular at that time.

Susan Hess died in 1917. Census records indicate that John P. Hess continued to live in the house through 1930, when he suffered a stroke which left him paralyzed. He then sold the house to his son, John J. Hess. In 1932, he died of pneumonia following a second stroke. According to his obituary, he died at 2400 Avenue D, where he had been staying for some time under the care of a nurse. The family of Daniel and Mary O'Connor lived at the house until it was sold by John J. Hess in 1937. John P. Hess and his wife Susan are buried in Walnut Hill cemetery. *Continued on next page*.

### GNA HOMES: 528 Clark Ave. — John J. Hess, by Mary Lou McGinn

John J. Hess, born in 1872, lived on the family farm and from age seven and attended country schools. After graduating from high school, he attended the Western Iowa Business College, spent one year at Grinnell College and one year at Highland Park College in Des Moines. He then entered the University of Iowa School of Law where, according to his obituary, "he was active in athletics and played fullback on the team." He graduated in 1895, returned to Council Bluffs and began the practice of law.

He established the Hess Law Firm in 1896.

Hess, distinguished in Iowa as a trial lawyer, was chairman of the board of First Federal Savings & Loan, a member of the board of directors of the Abstract Guaranty Co., served as Pottawattamie County attorney for eight years, was special assistant attorney general of Iowa for 15 years, was active in Republican politics, and was named king of the Council Bluffs Mardi Gras in 1947 for his service to the community.

On December 16, 1898, he married Belle Snyder who was born in 1877 in Favette County, Iowa, and came with her parents to

Council Bluffs at age three. The J.J. Hess family lived at 224 South Seventh Street - the present site of Bloomer School - until the purchased the house at 528 Clark Avenue in 1923.

The couple had two daughters: Geraldine, who married Douglas Peters, Sr., and Gretchen, who married his brother, Clarence Peters.

Geraldine and Douglas Peters had three sons: Peter, John and Douglas. All attended law school and joined the Hess Law Firm, which then became the Hess Peters Law Firm. Douglas eventually went to work for First Federal Savings & Loan; Peter and John stayed with the firm.

Gretchen and Clarence Peters had one son, Clarence Hess Peters - known as Hess. Two children from Gretchen's second marriage, to Gordon Smith, were Gordon, Jr. and Sandra.

The history of the house at 528 Clark Avenue began in 1906 when the area was platted. Based on courthouse records, it appears that Thomas Metcalf, Jr., president of The Metcalf Co., clothiers, built the house in 1912, moving from 519 Clark Avenue. Eloise Metcalf sold the house in 1923 to John J.

Hess. The Hess family lived in the house until 1952 when Belle died following a stroke. John then sold the house and went to live in the country with his grandson, Hess Peters.

The house was built in the Craftsman style, which was popular at that time. A subdued version of the Craftsman style, the house has a stuccoed first floor, wood shingled second floor, and a hip roof with cross gabled ells. The cantilevered porch hood over the front door has a diagonal brace, unique to the Craftsman style, as well as banded windows on the side elevation. The side porch was originally an open porch; the deck is a recent addition.

John J. Hess died in 1956 at age 84. The law firm that he founded, now Peters Law Firm, has been in existence for 119 years.

### GNA PET NEWS, by Jeff Ketcham

I recently had the fortunate occasion to meet with DJ, Gordon Hitchcock's Basenji.

About 4 years ago, after a negative experience with another dog, Gordon had said, "Find me a dog that doesn't bark, doesn't stink, and doesn't shed, and that'll be the dog for me," and as he says, he should have been careful what he wished for. Or at least been more specific as to where he'd find it. Shortly after that, a long time friend of Gordon's in the Washington, D.C. area contacted him about meeting a Basenji named DJ. After exchanging emails, pictures, and short videos featuring DJ's personality and traits, Gordon realized this was the dog he'd asked for, and he believes when you put a request out to the universe you shouldn't ignore the response.

DJ had been surrendered back to the breeder. As Gordon explained, basenji's are a unique breed and not for everyone. They're a domesticated jungle dog from the Congo in Africa. They've only been a domesticated breed since the 1950's and can come with some unique quirks and special needs. One of their more attractive qualities is that they are incapable of barking.



This is due to an evolutionary trait that developed as the breed was developed by Congolese tribes as hunting dogs. That isn't to say that they aren't vocal, they have a unique set of sounds that they can use to get your attention, some that resemble yodeling and as Gordon puts it, another that sounds like a tornado siren. They shed very little and have no undercoat, so they don't handle the cold well. They are incredibly athletic and intelligent dogs. Gordon explained that a fully developed male can do a standing spring jump over six feet in the air. It is the combination of energy, athleticism and intelligence that requires a special kind of owner.

Gordon explained to the breeder that he works from home and could provide the care and attention that DJ would need. So smitten with the prospect of adopting DJ, he drove to Washington, D.C. straight through the night. The very next day DJ was his dog; Gordon even has a picture of himself and DJ in front of the Lincoln Memorial Reflecting Pool in Washington.

Gordon has had DJ for 3 1/2 years, and in that time DJ has become family. Gordon told me a story about taking DJ to his mother's, as he goes to visit his hometown regularly to give massages (his profession). And usually when they arrive, DJ jumps into his mother's lap and greets 'Grammie' face to face. However, on one trip, they got in late and Gordon's mother had already gone to bed. DJ, not knowing what time it was, looked for 'Grammie' and when he couldn't find her, went to bed himself. When they were up the next day, DJ let Gordon's mother know his displeasure in not being greeted by first the cold shoulder and then a grumble when addressed. Gordon's mother said laughing, "I think I just got chewed out."

Gordon, Brian and DJ enjoy walking through Gibraltar, as the many retaining walls give DJ a lot of jumping practice. Gordon and DJ are also on the planning committee for the new dog park being built by the new Midland Human Society facility. Gordon states they hope to have it open by August.

Be sure to wave and say "hi" whenever you see DJ walking through our neighborhood!

Once again this year the Gibraltar Neighborhood participated in a fundraising effort for the General Dodge House by donating plants from our own gardens, with sales benefitting the Dodge House. **3.** Update on GNA Banners: Cory is working with the city on pole-mounted GNA identification banners. Chris Gorman and Cory drove the neighborhood to identify utility poles that would evenly distribute banners throughout the neighborhood. They paid particular attention to those poles that already have light fixtures on them which would better highlight our banners. Cost is approx. \$5000 for 25 banners (hence the application for grant monies). It was decided by those present that the banners would be the same pine green as on our current banners, with white lettering. Mid-American Energy would install them. Cory will check on whether there is an additional charge for that. Cory submitted a formal proposal to the City/MAE with our plan.

**4.** RE: Sidewalk Repairs. Cory will check with Steve Gorman if he has spoken to any possible contractors for the work (Steve has already mapped-out the areas in our neighborhood in most need of repair). Bob Rosser suggested chunking the work out incrementally. This is still a work in progress but extremely viable.

**5.** RE Social Events: Cory would like to access grant moneys to sponsor quarterly social events to reach out to entire neighborhood population. Several ideas were bandied about (Pancake Man, New Year's Eve at General Dodge House and food trucks to name a couple.) Our desire is to provide family-friendly events. Cory Peters and Jeff Ketcham will explore those options.

**6.** RE GNA Fundraisers: Various ideas were proposed – Movie Theater Night, Dodge House Holiday event (dinner or hors d'oeuvres and cocktails) were all discussed and tabled for another conversation.

**7.** RE Surveys: Only 6 surveys were submitted, all of which were generally positive. Some concerns were expressed about sense of community, so neighborhood outreach is important. The idea was floated that perhaps banners would provide a sense of identity and pride among neighbors.

**8.** RE Little Free Library: The pastor of Our Savior's Lutheran has presented to her board about hosting the library in the yard of the rectory. Meka Tate also told Cory that the Rotary Club is interested in being involved in this effort. She will follow up. Bob Rosser suggested that we design a GNA book stamp for the books as another outreach effort. Bob also generously offered us whatever books were not sold at his estate sale, so we can rotate books in and out on a regular basis.

Before adjournment, Cory thanked Mary Madison for agreeing to act as Treasurer with Bob Rosser's departure for new ventures in western Nebraska. A big thanks to Bob for his enthusiastic participation in the GNA. Best wishes to Bob and Ellen. You will be missed! NOTE: Mary is hoping that her stint as Treasurer is brief, so anyone who would like to take on those duties may contact Cory Peters.
