GNA Resident Receives National Honor



Neighborhood resident Patty Gillespie was in Washington, D.C. recently, where she was one of three Americans to received the title of National Reading is Fundamental (RIF) Coordinator. The National Co-

ordinator is chosen out of **17,000 coordinators from across the nation.** The coordinators assist over four million students in getting books each year. But her journey to the award might surprise you.

Gillespie learned to read when she was 19-years old. "It has given me great empathy," she said. "I understand how every struggling reader feels that's in my classroom." Gillespie said she made it into college by sheer luck. "Then I realized I couldn't make it if I didn't learn how to read," she said. "And I sat down with a book and said, 'I'm not going to get up until I know

what this book says." She is in her 34th year of teaching and is currently at Thomas Jefferson H.S.

Patty began the RIF program at T.J. when she became aware that students did not have access to books at home. After teaching all day, she uses her spare time to complete all the tasks involved in RIF. She writes the proposals and final year reports for the more than 2,000 books she orders for RIF. She also creates activities and materials to help motivate students to read. "I'm so excited. I was speechless for the first time in my life. I was blown away," exclaimed Gillespie about the award. Over 30 years, she has dedicated her life to helping other students learn to read. She now has a Masters Degree in Reading, but still understands the struggle that her students go through each day.

Congratulations, Patty, on being selected for this prestigious national award! ■

May General Meeting and Board Meeting Minutes

GNA General Meeting was held on May 10, 2011, at the home of Paulette Brandt and Dave Eyre. Larry Foster, Director of Parks, Recreation & Public Property, was the guest speaker.

A couple of the projects he is currently working on that are of importance to the community:

Fairview Cemetery needs to be brought up to city standards. It is the oldest cemetery in the city, and holds a lot of the history of Council Bluffs and its residents. It will take about \$1 million dollars to bring it up to date. The lay-back curves need repair, as they funnel all the water out and down the hills when it rains. Fairview is the only other "green space" in our local Historic Neighborhoods besides Kirn Park. The roads will need to be redone, as they have already been repaired over and over again. One of the roads will either need to be closed or eliminated.

Kirn Project: Larry said that he was so awed by Kirn Park, and its character really impressed him when came to work for the City. It has so much to offer, and repairs will be done to retain it as a historical point in Council Bluffs. There are many improvements that are scheduled over the next two years to support football, lacrosse teams, etc.

The GNA Board Meeting was held on May 16, 2011. Board Members Present: Bud & Susie Dew, Sheila Graham, Mary Madison, Paulette Brandt and Liz Matis. Paulette said she wanted to invite Mark Alba to a General Meeting in the future, as the GNA wants to set up a Neighborhood Watch. After organizing, the only other requirement is the Watch needs to meet twice a year. Liz said we need the signs that attach to the street signs, and the City would need to place them on the sign posts that are already present in our neighborhood.

Pride week will be taking place and the Gibraltar neighborhood will participate in the "Clean Sweep" project again. A BBQ will be held in Bayliss after the neighborhoods finish their clean up at 5:00 p.m.

Nate has put in a lot of hours on the Historic Core Initiative presentation that will be given to Iowa West.

We will be looking into a possible get-together with Fairmont NA for a picnic toward the end of the summer.

A History of Kirn Park, written by Connie Bartel

Saving Kirn Park was a "sentimental journey" for me. I lived in the house I live in now (116 3rd Street) when I attended Abraham Lincoln High School, located between 3rd & Bluff Streets at 5th Ave. My friends would gather at my house, and we would trudge up the hill (High School Ave.) to attend football games, track meets, ROTC parades and May Queen ceremonies.

In 1870, Iowa Governor Merrill came to Council Bluffs to dedicate the new high school, then located at the top of 5th Avenue. ROTC began there in 1892, and football and track were introduced in 1895. Crimson and blue were chosen as the colors, as they were the initials ("C" and "B") of our town.

Approximately 70 years later, the school would be gone, and in its place an athletic field, with football goal posts, cinder track and bleachers, built by the Public Works Administration. It was dedicated to G.W. Kirn. There were more than 1,000 people in attendance when the field was dedicated. Rev. J.R. Perkins, of the Congregational Church, did the dedication and Gen. Dr. Matthew Tinley crowned the May Queen.

It was in 1990 that the School Board announced its intention to sell the property at auction. A "Save Old Kirn Field" association was formed. I had counted and saved 31 articles written to the newspaper, protesting the fact that the public seemed to have no input. Mr. Christie delayed the auction, and the City Council agreed to help the citizens in their effort to take it off the auction block. Councilman Sam Irwin succeeded in making a zoning change for the property, from strictly residential to "parks, estates and agricultural." Suzanne Winter gave a fine presentation to the Council and later became the treasurer of the fund. I sent out 100 letters to my classmates, and one day my old friend Janeanne Braun Doar called me from California and said, "Connie, I have 10." I said that was nice, and she said, "No, I mean \$10,000." She wanted it sent as a memorial to her Mother, Ellen J. Jones, CBHS 1907. So, that is the top name on the Memorial at the Park.

Finally, the auction was held in March, 1990, and about 75 people gathered at the old field. Lyle Rodenberg made the highest bid — \$72,000, and donated the \$10,000 he put down to the fund. An additional \$62,000 was raised. Over 500 people contributed. The City Council contributed \$25,000. And, Jim Hawk, who had promised he

would donate once the field was bought, contributed \$25,000 (with some of this contribution going towards the purchase of playground equipment). Jim's wife, Beverly, was in my class in high school.

Attorney Scott Hughes handled all the legal business. The Parks Department has used money for improvements. The memorial stone was engraved with the names of Mrs. Jones, Phyllis and Lyle Rodenberg, Jim and Beverly Hawk, in honor of their son, and the Council Bluffs City Council. The memorial has a wonderful picture of the first High School in Council Bluffs.

Flood Information: What You Should Know

- (1) Please sign up for the Code Red emergency alert system. It is best to do so online (on the City's website: http://www.councilbluffs-ia.gov), though if you are unable to do so via the internet, you may call 712-328-4672, though expect a LONG wait to get through. Note: There is an option to indicate, when signing up, whether you are elderly or disabled, as those folks could need extra assistance should an evacuation be needed; these are the people who need most to sign up, though everybody should!
- (2) Until further notice, if the sirens go off DO NOT ASSUME THAT IT MEANS A TORNADO, but immediately turn on the TV or radio (a battery-operated radio may be a great investment, in case of loss of power) to find out what the emergency is. If a Level 3 (explained below) emergency is declared, the sirens in the affected zone of the City would sound, which would mean to get out in an orderly fashion and as QUICKLY AS POSSIBLE.
- (3) It is possible, as many City employees have been pulled away from their normal duties, that parks and other public places may not be mowed as often, or otherwise maintained to their normal high standards. If need be (and this is not yet a problem), it could be that neighborhoods could be invited to volunteer to mow and maintain the public spaces within their neighborhood, though notice to the City would have to be given before such things were done, to let them know. Again, this is not yet a concern, but could be, so please have your list of volunteers for this potential task ready.
- (4) The National Guard now has 4 units within the City, so you may see them around. They are being adequately housed and fed, so our assistance is not needed with that at this time; indeed, many businesses have been donating hundreds of pizzas, hamburgers, etc. A total of 250 National Guard members who are based at CB are scheduled to return from Afghanistan on the 23rd of July, and will likely relieve and bolster the current units.
- 5) As of 3PM Monday, the 13th, people are NOT ALLOWED EVEN TO WALK ON THE LEVEES; IF SOMEONE IS NOT SUPPOSED TO BE THERE, HE/SHE COULD BE SUBJECT TO ARREST. The pedestrian bridge remains open at this time, but only the straight shot across; you can't go north or south from it, only east towards the City. LET'S DISCOURAGE THE CURIOUS FROM GETTING IN THE WAY OF THE PROFESSIONALS AND THE VOLUNTEERS!
- (6) Indian Creek has been sandbagged, to allow at least 3 feet of wall above the current high-water projections.
- 7) All critical infrastructure has been sandbagged, THOUGH ADDITIONAL SANDBAGGING EFFORTS LIKELY WILL BE NEEDED, to have enough reserve sandbags to cover any problem areas; await further news as to when and where (though, note, the current effort, today, near the MidAmerican plant).
- (8) The current projection is that the water will remain high until at least January 2012.
- (9) Code Red would be used in the event of emergencies, though the City also has the use of the CB School District's calling system, which is able to target calls to people within elementary-school zones, so very targeted. Again, the sirens would not be used for flood-related purposes unless an absolute breach were to occur; the sirens cannot make a different sound or pitch, so they will sound the same whenever activated for whatever reason.

- (10) The City has had a 24/7 command center, based at Community Hall downtown, with all vacations through September canceled for most everybody. Every 3 to 4 days, different shifts from our fellow cities in Iowa are coming in to provide expert assistance, including from Des Moines, Cedar Rapids, and Iowa City (all of which, of course, have had terrible experience with flooding these past few years; they are returning the favors we have done for them during those years).

- (12)Summary of Levels:

Level 1: Take note, there is a potential problem

Level 2: It would be best to evacuate

Level 3: You must evacuate or be forced to do so

- (13) If an evacuation is ordered (Level 3), you may only bring a SMALL POUCH of personal belongings OR a small pet, nothing else. The processing center where all evacuated folks would be sent is Iowa Western Community College, and the City has lined up 80-100 buses to get people there if needed.
- (14) The City is currently uprooting trees located anywhere near the 28 miles of levees or other critical infrastructure, as a few have already fallen in the wet soil, and pose a major hazard if the force of falling were to hit anything; this is an expensive, though necessary, effort.
- (15) The City has 200 relief wells, which help collect water and relieve pressure on the levees. THEY ARE WORKING.
- (16) Some water on the dry side of a levee is normal and actually helpful; a lot of water or water rushing through IS NOT and must be reported to 911 IMMEDIATELY.



wedding present for the newly married couple. Also, this unique house was once visited by First Lady, Barbara Bush while visiting a previous owner, who was quite active in the Republican Party during the 1980s. In March of 2009, it was featured nationally on Good Morning America as one of the "Best Buys in America."

Larry Foster at GNA Meeting on May 10th, by Paulette Brandt

Larry Foster, Head of Council Bluffs Parks and Recreation Dept., attended the May 10th meeting of the Gibraltar Neighborhood Assn. He gave us and update on the plan for Kirn Park and for the Fairview Cemetery trail projects.

The plan for Kirn Park includes: re-grading of the track and a new layer of crushed brick, fixing the drainage of the track, re-grading and re-seeding the football field, adding an irrigation system, removing the concrete block building (the old restrooms) and the storage unit, paving that area and marking off parking places along that side of the field. Also, lighting will be enhanced and there will be some type of wall around the track to prevent driving on the track, which tears it up when the ground is wet. The fencing also will be addressed and landscaping will be added in some areas. The improvements can only enhance and welcome attendance to the Park.

The Fairview Cemetery Part of the plan is to close off some roads in the cemetery and pave for pedestrian use. Other roads will be repaved for motor vehicle use. Right now the Oakland/Fairview Assn. residents use the Cemetery, and walking trails and the improvements will only enhance that experience. Of course, use for funerals will not change.

RECIPE Corner:

Refreshing Summer Fruit Salad provided by Cory Peters

PINEAPPLE CREAM CHEESE DRESSING:

1/3 cup sugar
 1/4 teaspoon salt
 1/4 cup orange juice
 2 tablespoons lemon juice

2 eggs, lightly beaten

2 packages (3 ounces each) cream cheese, softened

SALAD:

2 cups sliced fresh strawberries

2 cups pineapple tidbits

1-1/2 cups seedless green or red grapes, halved

1-1/2 cups diced peaches or nectarines

1 cup fresh blueberries or raspberries

1/4 cup *sugar*

In a small saucepan, combine the sugar, cornstarch and salt. Stir in the juices until smooth. Bring to a boil; cook and stir for 2 minutes or until thickened. Remove from the heat. Stir a small amount into the eggs; return all to the pan, stirring constantly. Cook and stir until mixture reaches 160° and is thickened. Remove from the heat; cool slightly. In a small bowl, beat cream cheese until smooth. Add juice mixture; mix well. Cover and refrigerate overnight.

In a large bowl, combine the fruit. Sprinkle with sugar; toss to coat. Cover and refrigerate overnight. Serve with Dressing. Makes 8 servings. Great on hot days!
