
Kirn Park Project

Our Past, Present and Future: Folsom Everest

To prepare for GNA's future, we must know our past.

In this edition of Rock Talk we will meet a well known attorney from Council Bluffs, **Folsom Everest**. "Among the able, learned and thoroughly experienced lawyers practicing at the bar of Council Bluffs, few have a larger following or are held in higher public confidence than Folsom Everest. Aside from any consideration that may be given him because of his membership in an old and honored family of the Hawkeye State, his personal accomplishments have been such as to entitle him to esteem among men who recognize and appreciate his worthy qualities of others."

Mr. Everest was born at Grinnell. Iowa, November 21, 1894. Folsom Everest acquired his early education in the public schools of Council Bluffs, following which he was sent to the Peddie School, in New Jersey, one of the old and cultured educational institutions of the East. Upon his graduation he returned to Grinnell, and when the United States became embroiled in the great World War raging in Europe, in 1917, he enlisted in the United States army and was sent for intensive training to Camp Cody, Deming, New Mexico, where he remained for nine months. He then went to Wright Field, Dayton, Ohio, where he became commander of the Eight Hundred and Eighty-first Air Squadron, but was transferred to the Eighty-fourth Division, and in August, 1918, went to France with that division as a first lieutenant in the Three Hundred and Ninth Ammunition Train. He served in France until the signing of the armistice, and in 1919 returned to the United States. In 1920 he joined the National Guard and was commissioned captain of Company L, One Hundred and Sixty-eighth Infantry, and in 1923 took command of the Third Battalion of that regiment. In November, 1924, he was made lieutenant-colonel and adjutant of the Thirty-fourth Division, and still retains this rank.

Upon his return from France Mr. Everest entered Creighton University, where he graduated with the degree of Bachelor of Law as a member of the class of March, 1921. Shortly thereafter he successfully passed the bar examination and was admitted to practice. After practicing alone for about five years, in 1926, he became a member of the firm Tinley, Mitchell, Ross & Mitchell. This was one of the strongest legal combinations of Council Bluffs and Mr. Everest had been identified with much important litigation, in which he showed himself capable and thorough, a master of principles and precedents and a man thoroughly familiar with courtroom procedure. He was a valued member of the Pottawattamie County Bar Association, the Iowa State Bar Association and the American Bar Association. His religious connection was with the Congregational Church, and he held memberships in the Masons, B.P.O. Elks, No.531, National Sojourners and American Legion. He always displayed his civic pride in a practical manner, and was a member of the Greater Council Bluffs Association and the Rotary Club. A Republican in his political views, he attended most of the Republican conventions and was something of an influence in his party.

On June 14, 1921, Mr. Everest was united in marriage with Miss Elsie Tinley, daughter of Emmet Tinley, a prominent lawyer in Council Bluffs, a member of the firm of Tinley, Mitchell. They had three children: Mary Rose, born in 1923; Frances, born in 1924; and Emmet Tinley, born in 1926. Mrs. Everest was an active member of the Episcopal Church.

Jeremiah Folsom, the maternal grandfather of Mr. Everest, came to Iowa in 1856, and bought land from the Government, where he was engaged in agriculture for many years. At the time of his arrival, and for years afterward, the plains of Iowa and the military company at Council Bluffs which was the predecessor of Company L, One Hundred and Sixty-eight Infantry, the oldest in the Iowa National Guard, to fight the hostile Indians. This infantry has fought in every American war since. An interesting fact is that Mr. Folsom's Grandson, Mr. Emmet Tinley Everest, would later become its commander. We will meet Emmet Tinley Everest in our next edition of Rock Talk.

Be Aware of Identity Theft

Neighborhood Watchers, once you put your trash out for collection you lose your expectation of privacy. It is not against the law for someone to go through your trash (unless they are making a mess then it is a different story). This is why we talk about shredding any type of paperwork that may have your name on it. Dumpster diving is one of many ways a person can get your personal information. It is better to shred and then to be sorry.

All a thief needs is your Social Security number to commit identity theft. But once you know the facts and some preventive measures you can take, you can win the fight against identity theft! Identity thieves commit their crime in several ways:

- They dig through garbage cans or communal dumpsters in search of cancelled checks, credit card and bank statements, and preapproved credit card offers.
- They steal credit card payments and other outgoing mail from private, curbside mailboxes.
- They hack into computers that contain personal records and steal the data.
- They file a change of address form in the victim's name to divert mail and gather personal and financial data.

Clues That Someone Has Stolen Your Information

- You see withdrawals from your bank account that you can't explain.
- You don't get your bills or other mail.
- · Merchants refuse your checks.
- Debt collectors call you about debts that aren't yours.
- You find unfamiliar accounts or charges on your credit report.
- Medical providers bill you for services you didn't use.
- Your health plan rejects your legitimate medical claim because the records show you've reached your benefits limit.
- A health plan won't cover you because your medical records show a condition you don't have.
- The IRS notifies you that more than one tax return was filed in your name, or that you have income from an employer you don't work for.
- You get notice that your information was compromised by a data breach at a company where you do business or have an account.

RECIPE: Layered Salad – Liz Matis

Put 1 to 2 Tblsp each of salt & sugar in the bottom of a salad bowl.

Add 1 C. grated Swiss cheese over the salt & sugar.

Next, fry 1/2 lb. bacon, fried crisp and crumble. Add on top of cheese.

Hard boil 6 eggs, slice and place over bacon.

Add torn or shredded lettuce over eggs, plus some more salt & sugar.

Sprinkle one box frozen peas (not cooked) over lettuce.

Thinly slice 1 red onion and place over peas.

Mix 1/2 pt. sour cream with 1 C. mayonnaise.

Pour over salad and put more grated cheese to top. Let set overnight in the refrigerator.
