
### SAVE THE DATE for our September meeting – FALL POTLUCK!





#### Middle-Class Americans Dodge Homeownership Obstacles (June 2014)

As home prices and interest rates continue to rise, the number of middle-class Americans who can afford a home has fallen in many cities. Recent reports suggest middle-class buyers are being priced out of median priced homes in many cities. Among the most expensive metro areas, according to the National Association of Realtors®, are San Jose, Calif., San Francisco and Honolulu. Other data shows that only one in four homes for sale in New York and Los Angeles, and only one in seven in San Francisco, are within reach of those earning the city's median household income.

NAR Chief Economist Lawrence Yun pointed out other roadblocks for today's buyers, including difficulty qualifying for a mortgage and coming up with a down payment. Yun says, "Price increases have been a double-edged sword; it's been very good for owners or recent buyers because they're immediately getting equity, but it has not been good news in terms of affordability for potential buyers." ## Pet Corner interview with Galen Barrett of Council Bluffs Animal Control

Recently, there's been a bit of traffic on our email group regarding pets in the neighborhood. Everything from noise issues to questions of mistreatment. In an effort to equip ourselves with some knowledge on how to address these issues as they arise, we recently reached out to Galen Barrett, the Chief Animal Control Officer for Council Bluffs. We were able to ask him a number of questions.

GNA: If a neighbor's pets are causing a noise issue, what is the best approach for addressing the situation?

**Galen Barrett:** There are a couple different ordinances at play when addressing noise. City ordinance 4.50.060 addresses noise disturbances between the hours of 10 pm and 7 am. City ordinance 4.20.140(d), is an animal control ordinance and is not restrained by any time limits. It reads as follows: "No person owning or having an animal under his or her control or within his or her care or custody, shall permit such animal to create a noise disturbance as defined in Chapter 4.50, "Noise Control," or to bark or make any loud or unusual noises during times which such owner knows or should expect that such noise will disturb one or more neighbors, or otherwise disturb the peace. Kennels, veterinary clinics, animal hospitals, and animal shelters located within properly zoned areas shall be eligible for a variance from this requirement pursuant to the provisions of Section 4.50.070."

As far as the best approach for addressing those issues, I really prefer to have the person with the issue speak directly with the person owning the pet. Unfortunately, it seems nowadays, neighbors don't talk to each other. In many cases they don't even know the name of the person that lives next door. I promote open dialogue. While resolution of noise disturbances looks easy on paper, it is one of the most difficult for us to enforce. Most times, the noise disturbance is not witnessed by an Animal Control Officer. We have the complainant complete a "witness statement" which documents dates, times, duration of disturbance, etc. We will contact the pet owner and advise them that a complaint has been filed and give recommendations of how to mitigate the issue. Some complainants will video tape the neighbor's dog barking. That kind of evidence is incredibly helpful.

GNA: Are there any tips that pet guardians may not already know to help keep their neighbors and neighborhood peaceful?

GB: Here again, I am an advocate of open dialogue. When neighbors talk with each other, there tends to be a generation of mutual respect. If everyone walked their dogs on a leash, picked up after their pets, minimize their dog's barking, don't allow cats to roam the neighborhood, and spayed/neutered their pets, 95% of the complaints generated from pet ownership would be resolved.

GNA: What (if any) laws or statutes are there regarding the tethering or keeping pets outside unattended?

**GB:** Dogs are allowed to be untethered and unattended in a yard so long as the yard is fenced in a manner which does not allow the dog to leave its property. Dogs kept in this manner have to have access to shelter, food and water. A dog that is tethered must also have direct access to shelter, food and water. A dog's tether has to be at least 10 feet in length and be attached to the dog via a properly fitted collar or harness. Cats are a different story. So long as the cat is wearing a current rabies tag and city license tag on its collar; it is allowed to be at large. If the cat is found to be causing damage to property other than that of its owner, it is not allowed to be at large.

**GNA:** Finally, could you please shed some light on what your office considers actionable offenses and what is best handled between neighbors.

**GB:** Any violation of City ordinances in Chapter 4.20 is an actionable offense that can be addressed by an Animal Control Officer. If an issue can be resolved amongst neighbors, that is fine. When neighbors don't want to be "neighborly", give us a call. With that being said, if the issue is a case of animal cruelty, we should always be contacted. This is for the benefit of the pet.

From the very beginning of the GNA, one of our key objectives has been to increase the overall communication within the neighborhood. Judging by these responses, it looks like open dialogue and neighborly communication can be for the benefit of our pets as well as ourselves. We thank Mr. Barrett for taking the time to share this information with us!

### Council Bluffs Animal Control Division

The Animal Control Division manages areas dealing with domesticated animals within the City limits of Council Bluffs. These topics include the following.

- Pet Licenses
- Cattery and Kennel Licenses

### Council Bluffs Animal Shelter

The Animal Shelter offers a temporary home for cats and dogs who are lost, stray or unwanted. These pets can be adopted by the public for a small fee. Ads run in the local media to display the cats and dogs available for adoption.

Staff at the Council Bluffs Animal Shelter can direct you to the appropriate kennel, answer your questions, license your dog or cat, and fill out lost/found reports. The shelter also offers pet cremations and micro-chipping services. Micro-chipping provides an undisputable means of identifying your pet.

Animal Control Officers are also on duty to enforce animal control laws and rules and regulations, pick up strays and unlicensed animals, investigate nuisance, animal cruelty and complaint calls, locate and quarantine animals that have bitten a human or other animal, issue verbal or written warnings and citations, set cage traps for animals, vaccinate animals, offer euthanasia services, provide public education programs and inspect catteries and kennels.

Donations are always accepted at the Animal Shelter. Another method of providing additional support to the animals is by purchasing an item from our "wish list".

### Council Bluffs Bregant House listed on National Register of Historic Places

A little house just got a big honor. The Bregant House, the home of a famous little couple who met while performing on the same vaudeville program at Coney Island, N.Y. and then lived in Council Bluffs for years, has been listed in the National Register of Historic Places. Recognition ceremonies were held at the house at 517 Fourth St.

"It's a big deal," said Mary Lou McGinn, a member of the Preserve Council Bluffs organization. "It shows that this is a significant piece of property that deserves to be preserved, both the property and the history of its occupants."

The house was the home of Jean and Inez (Lewis) Bregant, a diminutive couple who met during the days of Vaudeville. Jean grew to 45 inches tall and Inez grew to 41.5 inches tall. "They were not midgets or dwarfs, just little people," said John Edwards, another member of the preservation group.

The home, built in 1912, is described as a simple Craftsman Bungalow, popular in the early part of the 20th Century. Ceilings and doorways were built to normal height for when normal sized friends came to visit the Bregants, but the fireplace, bathroom fixtures and kitchen appliances were scaled to fit the small couple. The Bregants lived in the house until their deaths – Jean in 1944 and Inez in 1969.

A \$1,500 grant from the Pottawattamie County Community Foundation provided the funding to seek admittance onto the history register. "It's a long process," McGinn said. "It takes about a year."







A: Mushrooms. An edible fungi, these are found in many shapes, colors and sizes. The white, umbrella shaped champignon de Paris was developed in France by King Louis XIV and is the variety that is most commonly found in supermarkets.
